

Development Services Fees

Effective January 1, 2017

BUILDING PERMIT FEES:

All-inclusive Building Permit Fee

\$8.00 per \$1,000 of Cost of Construction up to \$5,000,000, plus

\$4.00 per \$1,000 of Cost of Construction between \$5,000,000 and \$10,000,000, plus

\$2.00 per \$1,000 of Cost of Construction in excess of \$10,000,000

Minimum All-inclusive Building Permit Fee is \$45.00*

<u>Cost of Construction is determined by:</u>

Residential Construction: square feet (floor area x \$80.00 / square foot) Commercial Construction: square feet (floor area x \$125.00 / square foot)

Zoning Board of Appeals Application - Residential	\$120.00

TECHNOLOGY FEE:

A \$5.00 Technology Fee shall be added to all All-inclusive Building Permits, Standalone Trade Permits, Antenna Permits, Sign Permits, Site Development Permits, Demolition permits, Fence and Wall permits, and other similar permits issued by Development Services.
