PERMIT FEE WAIVER REQUEST FOR SEVERE WEATHER-RELATED DAMAGE

This form is to be completed by individuals or businesses seeking a waiver for permit fees related to repairs necessitated by damage from a severe weather event, such as a tropical storm, hurricane, or tornado. This form will be effective following a declaration of a State of Emergency for a specific severe weather event, when the City Manager may temporarily reduce or suspend any permit fees, application fees or other rate structures as necessary to encourage the rebuilding of areas impacted by the disaster or emergency. The term "fees" does not include fees collected by the city on behalf of the state or federal government or fees charged by the City pursuant to a state or federal statute or regulation. The City of Savannah reserves the right to request additional information to verify eligibility.

Instructions for Submission: Please complete and submit this form in conjunction with the permit application for work related to repairs necessitated by damage from a severe weather event. As part of this request, please provide photos of the damage, with time stamps if possible. Additional review time may be required if photos are not provided by the applicant.
