5. Permission is only valid for the individual, company or institution to which it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of.
6. Possession of reproductions does not constitute permission to reproduce or publish.
7. The City of Savannah reserves the right to refuse permission if it feels fulfillment of that request would be in violation of copyright law or other law.
8. Public, nonprofit, academic, and scholarly uses are encouraged. Requests for commercial for-profit uses are subject to review.
