

2024 Tentative Customer Bill Schedule

The City of Savannah provides this Tentative Billing Schedule to give our customers a general timeline of when they can expect a bill to generate and the subsequent due date. The City of Savannah currently issues utility bills approximately every other month or bi-monthly. *Please note:* Dates are tentative and actual billing dates may vary.

SPECIAL NOTICE

Due to prior delays, customers in billing cycle 6 can expect their final 2023 service period bill to be produced in January 2024.

Failure to receive bill does not relieve you of the obligation to pay bill.

How to read this schedule:

1. **Cycle** refers to service area (cycle numbers are found at the top of the bill above meter readings).
2. **Bill date** is the date the bill is generated and mailed to the account holder.
3. **Due date** is the date payment is due in our office (20 days after the billing date).

Important: Failure to receive a bill does not relieve you of the obligation to pay that bill. Please contact our customer service team if you have questions about the balance of due date of your utility bill.
