## About the Collection

This record group contains indentures, deeds, mortgages, quit claims, and tax notices for property acquired, purchased, or condemned by the City government. Property was either seized for non-payment of taxes or purchased by the City for public projects or street, sewer, canal or port improvements. The City also purchased property as it gradually expanded its borders, streets were widened or extended, and space was needed for rail and streetcar tracks and for electrical and telephone poles. Often the deeds are for only a strip of land along someone's lot, needed for widening a street, laying a rail, or deepening a canal. Many deeds include corporate seals and United States Internal Revenue Service (IRS) document stamps.

## How to Use This Index:

This index will help you discover deeds included in the City Council Meeting Papers – Deeds Collection. It lists the deeds by keyword, alphabetically by the first letter of the keyword, and then numerically by deed number. For example, all the “A” Keywords are grouped together. Within each letter, the index is arranged by deed number from smallest to largest.

## Tips:

- Sometimes there are more entries for a letter than there are lines available on the page, leading to the extra entries being recorded in a different place in the index. Be sure to check the document thoroughly for any overflow entries.
- Deeds may be cataloged by several keywords (ex: by a person's name AND the location). Brainstorm as many keywords as possible for best results.
- The lower the deed number, the earlier the deed was created. To narrow down the date of the deed, cross reference its number with the Finding Aid (available here: <https://www.savannahga.gov/DocumentCenter/View/501/Deeds?bidId=> )
