Name: City of Savannah, Georgia Records – City Court

Organizational History:

From the incorporation of Savannah in 1789, until the Mayor's Court was established by an act of the legislature in 1796, a Court of Aldermen tried minor offenses at City Council sessions (Gamble, p. 449). Court was thereafter held by the Mayor and Aldermen, until the Mayor assumed sole authority in 1815 (Gamble, p. 450). In 1819, due to the backlog of cases in the Superior Court, the Georgia legislature abolished the Mayor's Court and established the Court of Common Pleas and Oyer and Terminer, with an expanded jurisdiction. The Court of Common Pleas and Oyer and Terminer took over the records and pending cases of the Mayor's Court and was presided over by a judge, rather than the Mayor (Prince, Digest of Georgia Laws to 1837, pp. 491-498). In 1853, the name of the court was changed to the City Court of Savannah, and the law provided for a judge who was to be elected by the Mayor and Aldermen for a three-year term (Georgia Laws 1853-54, pp. 281-282). After 1905, the people of Chatham County elected the judge for a term of four years (Georgia Laws 1905, p.351).

The Court's criminal jurisdiction was extended from the Savannah City limits to the whole of Chatham County in 1868 (Georgia Laws 1868, p.165), and civil jurisdiction was extended to the entire county in 1881 (Georgia Laws 1880-81, p.571-572). The Court's jurisdiction on civil cases ranged from cases demanding less than \$50.00 in 1796, to settlements of up to \$500.00 in 1853, and finally, in 1881, to all civil cases, regardless of amount, except divorce, felony, land title, and equity cases which fall under the jurisdiction of the Chatham County Superior Court (Gamble, pp. 450, 453; Georgia Laws 1853-54, pp.281-282; Georgia Laws 1880-81, pp. 571-572).

The state court was established by a 1970 legislative act that designated certain existing countywide courts of limited jurisdiction as state courts, and the City Court of Savannah became the State Court of Chatham County (Georgia Laws 1970, pp. 679-670). State courts may exercise jurisdiction over all misdemeanor violations, including traffic cases, and all civil actions, regardless of the amount claimed, unless the Superior Court has exclusive jurisdiction. State court judges are elected to four-year terms in nonpartisan, countywide elections (www.georgiacourts.org).

The papers are arranged by a case number which is preceded by a letter(s). The letter(s) refers to the corresponding Record Book (Sub-series 5600CC-060) which contains a record of the case. Neither the set of case papers nor the set of record books are complete; there are many case files without the corresponding record books and vice versa. The Civil Minute Books (Sub-series 5600CC-050) also contain a record of these cases, however, these are arranged alphabetically making it difficult to cross reference with the papers.
