RECORD GROUP SCOPE NOTE:

This group contains papers from the Committee on Assessments and Licenses for Jitney/Vehicle Bonds of the City Council. "Jitney Bus" was a generic term for vehicles, hacks, automobiles or a motor bus that engaged in carrying passengers to and from any point in the City of Savannah. Every person operating a "Jitney Bus" was to pay a license on each car and had to submit a written application, to the Council, indicating route it was to cover and the number and class of vehicle to be used. These papers include applications made before the Council between 1910 and 1929 and referred to the Licenses Committee for handling.
