RECORD GROUP SCOPE NOTE:

This group contains papers from the Board of Pensions and Charities of the City Council. These papers include petitions made before the Council between 1912 and 1932 and referred to the Pension Board for handling. It was the responsibility of the Pension Board to examine all applicants for pensions as well as all pensioners for their physical and mental condition and report on their condition to the Council. Each petition contains the request, any supporting documentation sent before Council, and the report and decision made by the Pension Board. This group also contains petitions from hospitals, non-profit organizations, and charities asking the City Council for relief from taxes, appropriation of funding for projects and/or daily operations between 1919-1931. There is also a small group of correspondence between 1916-1932 on pensions and contributions to charities.
